### About us

The vision of the Australian Christian Lobby (ACL) is to see Christian principles and ethics influencing the way we are governed, do business, and relate to each other as a community. ACL seeks a compassionate, just and moral society through having the values of the Christian faith reflected in the character and political life of the nation.

- Assist in identifying strategic opportunities to execute nimble, effective campaigns for specific issues and during elections
- Energise the growth and success of ACL's political activities
- Volunteer recruitment, engagement, training, mobilisation, and leadership
- Help identify strategic opportunities to execute nimble, effective campaigns for both specific issues and during elections
