- Forge effective relationships across the business at all levels to drive the health and safety culture and change initiatives.
- Maintain and strengthen strategic relationships with FCDO and other key stakeholders to ensure FCDO Services interests are protected.
- Represent FCDO Services in dealings with external agencies and Partners Across Government (PAG) (i.e. HSE, Crown Premises Fire Inspectors, Insurers, Occupational Health Providers and Occupational Hygienists).
- Support the commercial bid team by provision of relevant and timely information.
- Ensure FCDO Services corporate governance arrangements for health, safety and welfare are in line with statutory and regulatory requirements and being met.
- Implement effective corporate processes for health, safety and welfare to ensure statutory and regulatory compliance, and drive continual improvement initiatives across FCDO Services.
- Strategic planning and delivery of FCDO Services Annual audit programme and in line with external audit compliance standards.
- Providing subject specialist expertise and leadership as well as influencing culture change initiatives across the organisation.
- Lead investigations into serious accidents, incidents and complaints and ensure FCDO Services interests represented/protected.
- Devise, develop and deliver appropriate health and safety training and education programmes for FCDO Services staff. Establish a high performance customer-focused health and safety culture across FCDO Services.
- Undertake continual professional development (CPD) and maintain professional expertise through networking, ongoing training and development.
- Maintain and strengthen strong working relationships with key stakeholders, external bodies and other government departments in pursuit of health and safety excellence.
- Embed the principles of inclusivity. Empower staff to develop knowledge, skills and competencies
- Hold and lead regular one to one meetings with staff to ensure effective delivery and continual professional development.
