## Specific Procurement Notice

Invitation for Bids FOR PLANT DESIGN, **Supply and Installation (Without Prequalification)**

**Employer:** Energy Development Corporation Limited (EDCL)

1. The Government of Rwanda has received financing from the African Development Bank hereinafter called the Bank toward the cost of the Transmission System reinforcement and Last Mile Connectivity Project (TSRLMC) and intends to apply part of the proceeds toward payments under the Contracts for Upgrade and Extension of Different MV Lines for Improved Substation and Upgrade of Karisimbi 6.6 kV Line to 30 kV. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the Bank's Disbursement Guidelines and procedures for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.
2. The Energy Development and Corporation Limited now invites sealed Bids from eligible Bidders for Upgrade and Extension of Different MV Lines for Improved Substation and Upgrade of Karisimbi 6.6 kV Line to 30 kV. The tender is in three (3) lots as detailed below and bidders may have the option to bid for any one lot or all lots. Bidders who intend to offer discounts in case they are awarded both lots will be allowed to do, if these discounts are explicitly stated in the Letter of Bid.

- (a) Bidders must have successfully completed at least two (2) similar plant design supply and installation works done within the last five (5) years of similar nature and complexity, each with a value of at least US\$11.7 million for Lot 1, US\$ 12 million for Lot 2 and US\$13.1 million for Lot 3.
  - (b) Minimum average annual turnover of US\$17.6 million for Lot 1, US\$18 million for Lot 2 and US\$ 19.6 million calculated as total certified payments received for contracts in progress or completed, within the last five (5) years.
  - (c) Additional qualification details are provided in the Bidding Documents.
3. Bidding will be conducted through the Open Competitive Bidding (International), OCBI procedures as specified in the Bank's [Procurement Framework](#) *Procurement Policy for Bank Group Funded Operations, dated October 2015*, IFB and is open to all eligible Bidders as defined in the Procurement Framework.





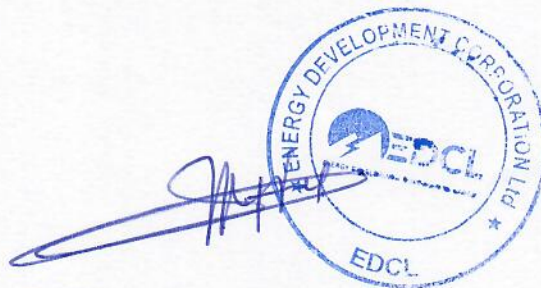
